Information annex

- According to the terms of the insurance, the spouse/partner and children (under 20 years of age) or, in their absence, legal heirs are beneficiaries.
- An insured person who wishes to choose a beneficiary other than the above must complete a beneficiary decree.
- · Anyone can be designated as a beneficiary.
- At the time of registration, we have not taken a position on whether the insurance is valid. If the
 decree cannot be enforced, compensation will be paid in accordance with the insurance conditions.
- A completed beneficiary decree must be sent to us immediately. In order for the decree to be applied, it must be received by us at least one month before the death.
- The insured person can revoke the order at any time.

Kammarkollegiet's processing of personal data in injury cases

Your personal data will be processed in connection with the handling of the claim.

When we take over the financial risks and liability for damages of other authorities, we need to process personal data in connection with handling the claim. The data are processed because they are necessary for the performance of tasks carried out in the public interest or as part of the exercise of our official authority.

Since we are a government agency and subject to the principle of public access to official documents, public documents containing personal data may be disclosed if they are not covered by confidentiality.

You have the right to obtain information about what personal data we process concerning you and to obtain an extract of the data with information about the processing, a so-called register extract.

The personal data we process must be accurate. If we process your personal data incorrectly, you have the right to request that the data be rectified and incomplete data completed. You also have the right to request erasure of personal data and restriction of processing. The ability of a public authority to comply with a request is limited because public authorities must comply with rules on public documents and archiving.
